OPEN ENROLLMENT PERIOD

Wednesday, November 1 through Wednesday, November 15. Enrollment is required every year, whether you already had an account or if you are new to the FSA.

MAXIMUM ELECTION AMOUNTS

For 2024*, the Health FSA annual election limit is \$3,050; the Dependent Care limit \$5,000.

* As of 10/26/2023, limits for 2024 had not yet been announced; changes are typically released in October/November.
