Five College Certificate in International Relations

The Five College International Relations Certificate Program offers an opportunity for students to pursue an interest in international relations as a complement to their majors.

Course requirements for the certificate:

- 1. A course on introductory world politics
- 2. A course on global institutions or problems
- 3. A course on the international financial and/or commercial system
- 4. A course concerning the historical development of the international system since 1789
- 5. A course on contemporary American foreign policy
- 6. Proficiency in a contemporary foreign language and / or completion of two years of the language at the college level or its equivalent. (For Amherst College students, the requirement is two years of college-level foreign language study.)
- 7. **Two** courses on the politics, economy and/or society of foreign areas, of which one must involve the study of a Third World country or region

Approved Courses

For requirements 1-5, the following courses are preapproved for the FCIR Certificate and offered regularly. Other courses may be substituted for the courses listed with the prior approval of the campus advisor.

For requirements 6 and 7, a wide range of courses are suitable and available every semester in the Five Colleges. Students should discuss their plans for completing the FCIR Certificate with their campus advisor and get approval for specific courses before enrolling in them.
